You must present at least 3 documents as your evidence of Identity:

- **2 Items from Category A and 1 Item from Category B** (at least 1 of these Items needs to verify your current South Australian address)

OR

- **2 Items from Category B and 1 Item from Category A** (at least 1 of these Items needs to verify your current South Australian address)

The 3 Items presented must together provide your full name, signature, date of birth and current residential address. If these documents do not verify your current residential address you **MUST** provide a 4th document from the list of "Evidence of Residential Address"

NOTE: If you have changed your name, and your name is different to the documents presented; you must provide evidence of "change of name".

	Overseas Birth Certificate showing parents details, WITH a passport or WITH an Official Travel Document.		If you are buying a unit or house, you are able to use water rates, council rates or land valuation notice up to 12 months old.
	Australian Passport (current or one that has expired within the last 2 years)		Occupational Licence (Consumer and Business Services) showing photo.
	Current overseas passport (with or without a Visa), or an overseas passport that has expired within the last 2 years); provided it is accompanied by a current Australian Visa.		Current Medicare Card, Pensioner Card or Department of Veterans Affairs Card or any current Entitlement Card issued by the Aust. Govt.
	A department of Immigration and Border Protection document for travel to Australia that is valid up to 5 years after issue.		Current Credit Card or Debit Card (that shows embossed name and signature) or an Account Card from a bank, building society or credit union, or a passbook up to 1 year old.
	Australian naturalization or citizenship document or immigration papers issued by the Dept. of Immigration and Border Protection including an Evidence of Australian Citizen Certificate or a "Citizenship by Decent" document		Complete an MR1418, "Confirmation of residential address and signature to enrol a client with the Registrar of Motor Vehicles" green form or a letter (up to 1 year old), from a bank, building society or credit union that shows your full name and demonstrates your signature has been verified by the bank, building society or credit union.
	Certificate of Identity or a United Nations Convention Travel Document issued by the Australian Passport office.		Armed Services discharge document up to 12 months old.
	A current or expired Department of Immigration and Border Protection "ImmiCard"		Australian issued firearms licence showing photo.
	Current Department of Immigration and Border Protection Visa Evidence Card (PL056)		Australian issued security guard or crowd controller licence showing photo.
	"Extract from Register of Citizenship by Decent" issued by an Australian embassy where parent(s) are Australian – born.

- **Evidence of residential address 4th document (if required)**

You may need to supply a document for Evidence of Residential Address, if your residential address is not included on a Category A or a Category B document.

"evidence of residential address"	
Certificate or statement of enrolment from an educational institution that is up to 1 year old.	
Letter (up to 1 year old) signed by the principal, deputy principle, head of school of a recognised educational institution; or a person with authority to sign on their behalf. This letter must be on the institutions letterhead which verified your address.	
Completed a "MR1418" form (This is available from a Service SA customer service centre) – and the Kilburn Flexicentre	
A letter from a bank, building society or credit union that shows your full name and demonstrates your signature has been verified by the bank, building society or credit union. (Statements and screen shots from financial institutions are not acceptable WITH or WITHOUT, the financial institutions branch stamps!)	
Last or current financial year Australian Taxation Office Statement (blank out your tax file number)	
Contract of sale, lease arrangement, or rental receipt for your place of residence up to 2 years old.	
South Australian drivers' licence or vehicle registration renewal for the coming period.	
Current South Australian vehicle registration certificate.
